CAN I HAVE A BIKE OVER £1000?

Yes, subject to your employer's consent you can have any value bike. There's no need for top ups or deposits. And you'll make savings on the whole value of the bike.



DOES IT HAVE TO BE ELECTRIC?

No, you can have any UK legal bicycle you like as long as you can commute on it. Accessories, spares, safety equipment and locks can also be included.

WILL I OWN THE BIKE?

Yes, although the scheme has to comply with tax regulations. This is all included in the arrangements and you won't pay any additional end of scheme fees.
